ADOPTION CONTRACT TERMS & CONDITIONS

In adopting the animal described within this contract, I agree to the following terms and conditions:

This animal will be humanely cared for including fresh food and water, appropriate shelter, veterinary care, love and respect.

This animal will be maintained in an adequately enclosed area or on a leash at all times. Felines will be confined strictly in the house. This animal will not be allowed to roam at will. **I am aware that felines adopted from CCA have not been vaccinated for leukemia as CCA adopts to indoor homes only.**

There are no restrictions or prohibitions on keeping an animal in the home, neighborhood, or on the premises. In cases where the home is rented, the landlord has given permission for the presence of an animal.

The animal will be checked and vaccinated annually with any other necessary veterinary care provided for infectious diseases, illnesses, or health maintenance as recommended by a licensed veterinarian and in accordance with any local ordinances. **If under 4 months of age, you will be required to provide a rabies shot and provide proof to CCA.**

If the adopted animal is lost or stolen, Concerned Citizens for Animals will be immediately notified.

The animal will not be sold, traded, turned into a shelter, given to any other individual or organization, or otherwise disposed of without the express written permission of Concerned Citizens for Animals.

The animal will not be put down without the express written permission of Concerned Citizens for Animals unless a licensed veterinarian deems it medically necessary or to end the animal's suffering.

If at any time the animal can no longer be cared for, Concerned Citizens for Animals will be immediately contacted and the animal returned to CCA.

The animal will not be used for medical or any other experimental purposes, used for fighting or any other inhumane activity, or sold/given to a pet store, supplier, or distributor.

It is understood Concerned Citizens for Animals may examine and make inquiries about this animal at any time, including a home inspection. If not satisfied with the condition of the animal or the conditions in which it is kept, CCA has the right to immediately remove the animal for placement in a different home. Any veterinary services needed due to negligence or lack of care will be the adopter's responsibility. Full payment for such services will be made to Concerned Citizens for Animals within 30 days of presentation of an invoice for charges.

Concerned Citizens for Animals makes no guarantees or warranties regarding the health or temperament of this animal.

Adopter(s) agree to be solely responsible for this animal and to indemnify and hold harmless Concerned Citizens for Animals, its employees, volunteers, and assignees from any and all claims of liability for the conduct of the animal on or after the date of this adoption. This Release of Liability and Indemnification shall apply to all known, unknown, and/or unanticipated damages resulting from the adoption, ownership, and control of this animal.
